It is recommended to stay in the same level all year to get the most out of the program.

Creative Ballet is the exception if the child has aged up and matured.

Parent Demonstrations will be held on April TBA for the last 15 minutes of class for Preballet and one hour for Levels 2 - 5.

CBT Spring Ballet Recital features selections from our new classical ballet "Alice in Wonderland".

Racquet Club, CMDS, SAA, Roulhacs and Second Baptist students will be in the Children's Ballet Theater Spring Recital Sunday, May 21 on the Hutchison School stage. Your child must be in a PKJK preballet class or older to participate. (2.5 year olds don't participate in recital).

There will be two performances. Students participate in one show and this info is TBA. (Exception: Levels 3, 4 and 5 dance in both shows.) There will be a REQUIRED dress rehearsal on Friday, May 19 from 4:00 to 7:30 pm (only Levels 4 & 5 attend the entire rehearsal). PKJK (3 & 4 yrs olds) DO NOT come to dress rehearsal but instead practice 45 minutes prior to showtime onstage.

There is a \$65 fee to participate in the recital which has already been added to your tuition fee. This covers stage rental/technical costs, two parent tickets (given at the dress rehearsal or the show day), and your child's pull on tutu skirt which she will keep or rental fee for costumes.

All children should wear a class leotard, tights and hair in bun for recital. Tickets will be \$15 sold at the door and supports expenses for the recital. Please invite your friends and family! Cash and checks only.

WAIVER OF LIABILITY, INDEMNITY AGREEMENT, AND ASSUMPTION OF RISK

In consideration of permission to use, today and on all future dates the property, facilities, and services of Children’s Ballet Theater, Memphis Youth Musical Theater, Racquet Club, Christ Methodist School or Church, Roulhacs, St Agnes, Second Baptist or Lipman School Ballet, (CBT programs) I, on behalf of myself, my heirs, personal representatives, or assigns, do hereby release, waive, discharge, and covenant not to sue, CBT programs, its directors, officers, contract workers, volunteers, independent contractors, and agents from liability from any and all claims arising from the ordinary negligence of any agent of Children’s Ballet Theater or any of the aforementioned parties.

This agreement applies to 1) personal injury (including death) from accidents or illnesses arising from the participation in our Ballet School activities including, but not limited to, organized activities; classes; observation; performances at GPAC theater, Buckman Theater or any other theater; and individual use of facilities, premises, or equipment; and to 2) any and all claims resulting from the damage to, loss of, or theft of property.

Indemnification and Hold Harmless: I agree to HOLD HARMLESS AND INDEMNIFY Children’s Ballet Theater from all claims resulting from negligence and to reimburse them for any expenses in investigating and defending a claim or suit if my claim is withdrawn, or to the extent a court or arbitration determines that Children’s Ballet Theater is not responsible for the injury or loss.

Severability and Venue: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of Tennessee and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Likewise, I agree that if legal action is brought, it must be brought in Memphis, Shelby County, Tennessee.

Acknowledgement of Understanding: I have read this waiver of liability and indemnification agreement and fully understand its terms. I understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by the State of Tennessee. The undersigned parent and natural guardian does hereby represent that he/she is, in fact, acting in such capacity, has consented to his/her child or ward’s participation in the activity or event, and has agreed individually and on behalf of the child or ward, to the terms of the accident waiver and release of liability set forth in Section 1. The undersigned parent or guardian further agrees to save and hold harmless and indemnify each and all of the parties referred to in Section 1 from all liability, loss, cost, claim, or damage whatsoever which may be imposed upon said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian. I hereby waive any claim of liability on behalf of Children’s Ballet Theater programs, for any efforts to obtain treatment from a doctor or hospital for my child in event that my representative or I cannot be reached.

IMPORTANT - REFUND POLICY

75% refund is given if a student withdraws within 24 hours prior to a second class. No refunds will be given after this time except in the case of a physician-verified illness. There is no pro-rating and no makeup classes. Tuition is not transferable to another session. Students cannot attend class until full payment is made. There is a \$30 fee for cancelled checks. CBT reserves the right to cancel classes due to inclement weather conditions or teacher illness. In the event of a weather condition, call the CBT office one hour prior to your class time at 921-0388 for a recorded message. There are no makeup classes for weather conditions.
